

**Modification Descriptions**

Add turn lane to project scope per KYTC-Flemingsburg HDO request. Project is considered exempt from the requirements to determine conformity based on 40 CFR 93.126 *Table 2 Exempt Projects – Safety – Highway Safety Implementation Program (HSIP)*. This project does not add capacity. KYOVA’s 2018-2021 TIP, MTP and Participation Plan includes HSIP projects as “Groupable” with *BG-126 – Highway Safety Improvement Program (HSIP)*.

**Justification**

To modify KYOVA’s 2018-2021 TIP, KYOVA’s MTP, and the current KY STIP to include an additional left turn lane location to project #09-403.00 (see #5 above) funded by KYOVA suballocated funds (SAH) through the Surface Transportation Block Grant Program (STBGP).
