Federal laws and regulations established with the current transportation bill and any subsequent extensions (Continuing Resolutions), requires Metropolitan Planning Organizations (MPOs) to publish a listing of federally obligated projects that were funded during the previous state fiscal year. A federal obligation is the Federal government's legal commitment to pay the Federal share of a project's cost. An obligated project is one that has been authorized by the federal agency and funds have been obligated. Projects for which funds have been obligated are not necessarily initiated or completed in the program year, and the amount of the obligation will not necessarily equal the total cost of the project. For FTA projects, obligation occurs when the FTA grant is awarded. For FHWA projects, obligation occurs when a project agreement is executed and the State/grantee requests that the funds be obligated. KYOVA, as the designated MPO/Transportation Management Area (TMA) for the Huntington, WV-KY-OH Urbanized area is required to fulfill the requirement to publish a listing of federally obligated projects within KYOVA planning area.

23 CFR Section 450.334 states:

- a. In metropolitan planning areas, on an annual basis, no later than 90 calendar days following the end of the program year, the State, public transportation operator(s), and the MPO shall cooperatively develop a listing of projects (including investments in pedestrian walkways and bicycle transportation facilities) for which funds under 23 U.S.C. or 49 U.S.C. Chapter 53 were obligated in the preceding program year.
- b. (b) The listing shall be prepared in accordance with § 450.314(a) and shall include all federally funded projects authorized or revised to increase obligations in the preceding program year, and shall at a minimum include the TIP information under § 450.326(g)(1) and (4) and identify, for each project, the amount of Federal funds requested in the TIP, the Federal funding that was obligated during the preceding year, and the Federal funding remaining and available for subsequent years.
- c. (c) The listing shall be published or otherwise made available in accordance with the MPO's public participation criteria for the TIP.

This report is completed to meet the above-mentioned criteria by listing all federally funded transportation projects in the MPOs urbanized area that were obtained during the State Fiscal Year (FY) 2026 (July 1, 2025 to June 30, 2026). The work obligated refers to the Federal government's financial commitment to pay or reimburse the lead agency for the federal share of a project's cost. Obligation in no way refers to the expenditure or project completion; but only that the specific project has been marked and approved for federal reimbursement.

The following report details projects that obligated federal funds in Cabell and Wayne Counties, West Virginia and Lawrence County, Ohio and documents federal funds obligated by West Virginia Department of Transportation (WVDOT), Ohio Department of Transportation (ODOT), Tri-State Transit Authority (TTA) and Lawrence County Transit (LCT).

The information provided is consistent with the project information listed in the KYOVA 2026-2029 Transportation Improvement Program (TIP), i.e., projects are shown with project identification

numbers, route, section, location, description, and funding amounts. This obligated project list presents information regarding the amount of federal funds that were authorized during fiscal year 2026, “other” funding amounts during fiscal year 2026, and previous funds authorized.

The report’s purpose, other than that of listing federally obligated transportation projects, is to provide an increased transparency of government spending on transportation projects and strategies to state and local officials and to the public. To realize this federal objective, a proactive approach to sharing information with the public in a user-friendly format has been provided in this report. A copy will also be made available on the KYOVA website (kyovaipc.org).

During FY2026, KYOVA Interstate Planning Commission, cooperatively with the West Virginia Department of Transportation (WVDOT), Ohio Department of Transportation (ODOT), Tri-State Transit Authority (TTA), and Lawrence County Transit (LCT) developed the following list of projects that were federally obligated for Cabell and Wayne Counties, WV, and for Lawrence County, Ohio.

*Note: The Ohio Department of Transportation (ODOT) provided the highway and transit project data, but there were no FY2026 federally obligated funds reported for Lawrence County Transit (LCT).
